1. CALL TO ORDER

6. OPEN SESSION

A. Excess Workers' Compensation Program Audit Results

Angela Hatley (Broker, Alliant Insurance) briefed the Board as to the findings of the recent Excess Workers' Compensation Program audit by Safety National, SIPE's excess carrier, for the 2023-24 policy year. Ms. Hatley explained that while estimated payroll reported on the renewal submission application was \$558,471,697, the audited payroll totaled \$631,748,676. The discrepancy resulted in an additional premium due of \$39,569.

Payment was made pre-emptively by SBCEO on behalf of SIPE, and the Board was asked to accept the results of the audit and ratify the release of funds in response to the audit findings.

B. Final Excess Workers' Compensation Policy for 2024-25

Amber Anderson (Program Administrator) advised that excess workers' compensation (EWC) coverage with Safety National Casualty Corporation was renewed as of July 1, 2024, and the final policy was received in December 2024. The policy was provided as part of the agenda to ensure receipt by all members. Additionally, the Board was reminded that through this partnership districts also are provided Safety National's Crisis Prevention Protection benefit free to charge.

C. Establishment of Rates Committee

President Lewis described the goals and responsibilities of the SIPE Rates Committee, formed annually in order to:

- Review SIPE's net position
- Consider the most recent actuarial report findings
- Discuss claims trends and other relevant information
- Provide a recommendation for a funding rate for the coming program year

The Committee will meet prior to the March 24, 2025 Board meeting in order to have a recommendation to deliver at that time for the 2025-26 program year.
